2017 NCBA Rules Committee Meeting Itinerary 10:00 am EST – OPEN MEETING

ELIGIBILITY

- > Full time to be 9 credits/hours instead of 12 for undergraduates
- > 7.03.2: Should this rule include transfer/withdraw students
- Adding "January 1" to 8.02.0
- 7.07.2: Allowing a player to compete with the team from the university he graduated from or allow it to be a transfer schools as well
- > 7.07.0: Adding exception for school sponsored study abroad program
- > 8.01.0: Removing academic warning or probation from
- ➤ Rule 7.09.0 increase 6/5 clock for Community Colleges
- Remove age limit to allow more players





ROSTER

- Allowing teams with both DI and DII teams to have more than 3 moves between teams
- Allowing teams with both DI and DII teams to be able to move a single player more than once but not more than 3-moves per year
- Reduce Roster Size to 28 to provide more competitive balance
- Allowing more players to be removed off of roster
- Adding 2 roster spots for documented season ending injuries
- ➤ 6.04.1.2: Add in a player or rep of current team or transfer team may contact NCBA by the appropriate deadline to have name removed from roster
- Move Roster Freeze Date Up

SCHEDULES/SCHEDULING

CONFERENCE PLAY

1.07.1 changing to "from the schedule to reschedule conference games" to allow for changes not related to rainouts





SCHEDULES/SCHEDULING CONTINUED...

CONFERENCE PLAY CONTINUED...

- ➤ If team completes one game (7 innings) and reschedules DH to another weekend is the DH, two 7's or a 7 and a 9
- If a makeup conference series is played mid week, can all games be 7's if approved by regional director
- 4.02.2.2 Single makeup game rescheduled to weekend be played as a 7 inning game
- Can tripleheaders be played as all 7's, or does one game have to be a 9-inning game
- Add Friday can be considered a mid-week game
- Adding, games can only be rescheduled due to uncontrollable circumstances

NON CONFERENECE PLAY

Inter-league games played between same school can count two games but they don't count towards required NC games for post season





IN GAME

- Outlawing noise makers in dugout
- DH for any position
- Adding "AUTOMATICALLY" to rule 5.05.0
- Students can ump games if not affiliated with a team or allow students to umpire if they are scheduled through an assigner
- Halted Games: Can a player participate if the player was added to roster after game was halted but before restarted? See Discussion Points
- Adding (.3) to 5.02 "position player listed as manager/head coach, and conference that stops play shall be charged as official visit"
- Adding (.3.1) to 5.02 "example: if catcher is listed as the manager/head coach, and conference between them will count as an official defensive visit"
- Change mound visit rule to match MLB
- 3rd to 1st becomes a balk?
- Slide rules need addressed. 19.01.1.2 runner should be ejected and play subject to interference rules? See notes
- Adding penalty for illegal substitutions





PROTESTS

- All Roster Violations become Off-Field Protest
- Protest of Roster Violations must be made at ground rules or when sub that is not on roster enters the game
- Adding "see protest rules" to section 6.02.1
- If players are in registration queue or on academic letter but not both, they can be retroactively activated to the roster to avoid forfeit
- If roster violations remain On Field, punish teams for use of ineligible player(s) that play
- Adding "and the catcher has left the dirt circle are at home plate" to rule 24.02.2.1
- Adding "Failure to schedule Qualified Umpires" to Off Field Protests
- ➤ If umpires are late (30 min or more), protesting team must protest before start of game and a forfeit will be requested





EJECTIONS

- Add "repeat offender" rule for player and coaches ejections
- No auto suspension for arguing balls/strikes by player
- Adding (.2) to Rule 22.03.1 (Coaches Ejections). "a player/coach that is ejected can be replaced by another player/coach who must be identified to the home plate ump and opposing team."
- Allow protests based on NCBA rules to be part of on and off field protests to determine if rules have been provided by home team

FORFEITS

- Can teams add stats to games that are played but end up forfeits
- ➤ If a team two teams agree to not play or one team forfeits during the last weekend of the regular season but the forfeits have no impact on standings, should the team be placed on probation
- ➤ Adding rule to 23.04.0 that if away team ends up forfeiting after game starts due to ejections, they will also be responsible for umps and field costs





POST SEASON

REGIONAL/DISTRICT PLAYOFFS

- The championship Game is a single elimination game
- Rain Delay procedures: Can a 2-0 team be crowned?
- Standardize Regional Bracket
- Not having Regional Game 3 be elimination game
- Game is complete if 5 innings played and play is suspended
- Should team qualify for post-season tournament and choose not to go due to school conflicts that they will not be penalized
- Clarify Tie Breaker rule 3.01.7. See Notes
- 3.03.3.1.2 Adding Overall wins before Top 20 Poll
- Adding Coin Toss after Top 20 in rule 3.03.1.1
- Removing 3.03.1.3.1 (1v4 can't be from same conference)

- Enforce/Stress Coaches Uniform Rules
- What contrasts with Camo Jerseys/Ban Camo Jerseys
- One number per player & one player per number
- Further define undersleeve color in rule 9.01.1
- Allowing BESR Bats
- Get rid of mandatory Richardson Hat
- Updating Hat rules to "The Game" as the new official hat sponsor
- Provide opt out for teams required by school to use specific hat brand

SPECIFIC LEAGUE RULE CHANGES

DIVISION 1 RULE CHANGES

- > 26.01.1: Stats from the entire team must be uploaded for POW/PIW
- Allow reentry and courtesy runners
- 9 inning games to 7 inning games
- Have all teams submit 2 academic letters; Fall Games Count
- Allowing Mid America Teams to play Fall Conference Games
- Allowing Fall season to count for all DI teams that choose to participate
- Adding NAR & GLR teams are NOT required to play Fall Conf

DIVISION 2 RULE CHANGES

- Remove automatic promotion to DI. Review on case by case basis
- Expanded use of automatic DI to DII and DII to DI moves
- Add Performance Bond for DII Teams
